 - o Eric distributed May's finance spreadsheet. Reviewed the spreadsheet.

 - Received bill for April Landscaping. Reached out to Landscaper to have some of the billed services explained. Waiting for a response back from them.

Landscaping

The next service that will be approaching is the first pruning. Targeting last week in May or First week in June. Special instructions to address the overgrown bush in front yards next to light posts.

• Community Picnic

 The board is reaching out to residents to see if any interest in having a community picnic. Will send out survey to residents to see if there is interest and what month works best.

2019 Services

- Bellas Army for Power Washing and Painting of Buildings Redwood 400 408 and Redwood 410-416 Target July 2019.
- o Road Base Repair (Mill & Pave). Targeting work for end of June / second week in July.
- Capital Projects Discussion (Roads, Roofing, Siding and Insurance)
 - o Roads Board voted to go with the Base Repair option. That is mill/excavate area to a depth of 4", pave with 4" of 25mm asphalt and roll/tamp for compaction. The board is voting on which provider. Price is approximately 33K. From both providers we received bids for driveway overlays and sealing. Once the board picks a contractor we will communicate the sealing and driveway pricing to residents. Targeting work end of June / week after July 4th.
 - Roof Assessment Discussed resident and owner input we have so far. Some concerns discussed were already addressed in the FAQ sent out, but other specific concerns were flexibility in payment, for instance some folks could find it easier to pay all at once, some do not have the cash flow for \$100 a month and not all work will take place at once. It was suggested and agreed we seek additional input, with the understanding we may get 52 different requests and may not be able to implement all of them but we want to be as flexible as possible so an electronic survey is going to be sent with some

options that are aimed to address ideas and concerns already discussed and an opportunity to provide additional ideas or feedback as well. Once received, the board will review and revise the proposal to include what is possible and send back out to residents, with an explanation of the suggestions and the results.

The vote for the proposal will take place in August.
